## **Changing Workplaces Review Special Advisors' Interim Report**

VPI Working Solutions has carefully and thoughtfully reviewed the Changing Workplaces Review Special Advisors' Interim Report, and is thankful for the opportunity to provide comments and submissions in response to the report.

As a smaller organization with fewer than 200 employees, we pride ourselves on being an employer that for the most part provides a greater benefit than required under the Ontario *Employment Standards Act, 2000*.

Although we recognize the need for a review of current employment practices we are concerned with many of the recommendations put forth in the Interim Report; there are certain recommendations that would impose significant financial burdens on small and medium sized companies and may discourage new business opportunities in the Province. We strongly encourage the Special Advisors to take into consideration the negative impact these proposed recommendations will have on employers.
